- Full compliance with all environmental regulations at international, national and local level, to deliver optimal activities with a view to continuous improvement of environmental performance.
- Collaborate with customers and suppliers so that environmental management becomes a factor of competitiveness within the national and international market.
- Maintain a high level of listening and communication of all internal and external stakeholders in a perspective of transparency and sharing.
- Continuous monitoring and reporting of environmental aspects that characterize the activities and setting of goals and targets annually re-evaluated.

  - collaborate with key stakeholders to contribute to solutions to local and global environmental challenges, including exploring pathways to net zero emissions.
  - continuous monitoring of consumptions and adoption of rigorous maintenance criteria.
  - equip our employees with the knowledge and skills to increase their expertise and sensitivity on environmental issues.
  - engage leaders and employees across the business to enhance our environmental performance.
  - support initiatives focused on responsible tourism, the protection of natural capital and biodiversity, and action against the illegal trade in wildlife.

It is a precise commitment of Airport Handling to combine the value of respecting and safeguarding environmental heritage with competitiveness and business development.

The adoption of an Environmental Management System represents a further confirmation of the company's effort and attention to the market in which it operates, by preserving the Environment for both Airlines and Passengers who choose them for their travels.
