

NOTICE ABOUT COOKIES

UE Regulation 2016/679 and the Italian regulation in force establish the right to personal data protection. These regulations prescribe that personal data processing has to be performed respecting rights and fundamental freedom, as well as dignity of the subject, having specific care about confidentiality and personal data protection. As per provision by Italian Privacy Authority dated May 8th, 2014 ("*Simplified Arrangements to Provide Information and Obtain Consent Regarding Cookies*"), **Airport Handling S.p.A.** (hereinafter Airport Handling) supplies the following information about cookies installed on www.airporthandling.eu website (hereinafter the website). Our website uses first-party technical cookies about which we supply information in accordance to the regulation of reference with the aim to enhance your experience.

WHAT ARE COOKIES?

Cookies are files sent from a website in which they are stored and saved in the user's browser. They record the activity on the website to make the browsing smoother and personal.

WHAT TYPES OF COOKIES DOES OUR WEBSITE USE?

DEPENDING ON THE ENTITY MANAGING THEM

Own cookies: These cookies are those sent to the user's device from equipment or a domain managed by the owner itself and from which the service requested by the user is provided.

ACCORDING TO THE LENGTH OF TIME THEY REMAIN ACTIVE

Session cookies: This is a type of cookie designed to gather and store data while you are accessing our website.

Persistent cookies: This is a type of cookie recording data stored on the device to be accessed and managed for a specific period of time, which may span from several minutes to several years.

ACCORDING TO THEIR PURPOSE

Technical cookies: This type of cookie is needed in order to allow the user to browse the website and use the different options and services; they are needed by the website to work properly. For instance, they allow: traffic monitoring and data communication; entry to restricted access sections; to remember the elements included in an order; to send in invitation to subscription or participation in an event; use of safety elements and content storage in order to show videos or share content through social networks.

CONSENT

Cookies acceptance and revocation

By browsing and continuing to use our website, clicking on the “Accept” button or on any other part of the page you are consenting to the use of the cookies listed above and the cookies will be set and collected for the website. In case of non-acceptance of the cookies through exiting the browsing, there is no “Reject” button; possible cookies already locally recorded in the browser will remain recorded there but no more read or used by Airport Handling until the next and related Cookie Policy acceptance. There will always be the possibility to remove those cookies at any time through the instructions described in the following paragraphs.

1. Purpose of data processing

The purpose of the cookies used on our website is the following:

1. Session monitoring

2. Nature of data collection and consequences of refusal to reply

With reference to point 1 at the previous paragraph, the installation of the cookies is not subject to former consent of the user, being it strictly necessary to perform communication transmission on a network of electronic communication. The processing will be performed with automatic systems adequate to record and manage data in total respect of the purposes written above so to grant confidentiality and security.

3. Range of data communication and diffusion

For the purposes written above, data could be communicated by Airport Handling to:

- all the subjects authorized to access those data and recognized in force of regulations;
- to our partner, employees, consultants and suppliers within their competence.

4. Identification of the data controller and processor

The Data Controller according to the Privacy Code is Airport Handling S.p.A., with registered office in Somma Lombardo (Varese), Aeroporto Milano Malpensa 2. The privacy delegate in charge to data processing according to the Privacy Code is Airport Handling Managing Director. Within Airport Handling, people authorized to process data have been appointed.

Data will be processed by employees and collaborators of the Data Controller, in their role of authorized and responsible for the data processing. A full and updated list of the Data Processors appointed by the Data Controller can be obtained sending an email to privacy@airporthandling.eu. Data collected through cookies will not be disseminated.

5. Rights related to art. 15-22 of the Regulation

With reference to data processing, the subjects have the right, in accordance to articles from 15 to 22 of the UE Regulation 2016/279 and where applicable, to obtain from the Data Controller the modification, the integration and the cancellation (so called right to oblivion) of their personal data; the right to obtain the limitation of the processing and the right to data portability; the right to object to personal data processing, included the possible profiling and, in the end, the right to complain with the Privacy Authority sending an email to privacy@airporthandling.eu.
